Proposed changes to Master Design Committee Guidelines

CHANGE PARA 15

FROM:

15. COMPLETION OF PROJECTS

The first project, constructed on any parcel, must include the Main Residence. All projects requiring a **construction deposit**, an **application fee** or a **processing fee** must be completed within twelve (12) months from the Master Design Committee approval date, and will be subject to fines, unless and until the owner is granted an extension to be approved by the Master Design Committee.

TO:

15. COMPLETION OF PROJECTS

- 15.1 All projects requiring a **construction deposit** or an **application fee** must be completed within twelve **(12)** months from the Master Design Committee approval date, and will be subject to fines, unless and until the owner is granted an extension to be **approved by the Master Design Committee.**
 - 15.2 All projects requiring a **processing fee** must be completed within twelve (12) months from the Master Design Committee approval date, and will be subject to fines, unless and until the owner resubmits the project for **approval by the Master Design Committee.**

Justification: Small projects should be completed within 12 months. If not the owner should resubmit the package. This would not apply new construction.

CHANGE PARA 3

FROM:

3. REVIEW PROCESS

After the receipt of ALL the required items on the check list, as well as a copy of the approved County building permit by the Master Design Committee, he committee has 30 days (the "Approval Period") to approve or disapprove your submittals. Be aware that the Approval Period starts when the Master Design Committee receives ALL required submittals.(NOTE: The Master Design Committee dates the package the day the Committee receives them, not the day you mail them.) If the Master Design Committee fails to approve/disapprove the submittals within the Approval Period, Master Design Committee approval is presumed given. The Approval/Disapproval letter will be deemed sent out on the date it was mailed, posted certified mail. *Pleas us 3 Canyons CCYR's* 12.3.5 Architectural and landscape Control. Upon completion of the Approval Period, you will receive written notification of approval or disapproval.

TO:

3. REVIEW PROCESS

After the receipt of ALL the required items on the check list the committee has 30 days (the "Approval Period") to approve or disapprove your submittal. The submission will be assigned to a Master Design Committee member who will review the submission with you to ensure the Master Design Committee has all the information required to review your submission at the next meeting of the Master Design Committee. If the Master Design Committee fails to approve/disapprove the your submittal within thirty (30) days after you are contacted by a Master Design Committee member, Master Design Committee approval is presumed given. You will receive written notification of approval or disapproval after the next Master Design Committee meeting. The Approval/Disapproval letter will be deemed sent out on the date it was mailed, posted certified mail. *Pleas us 3 Canyons CCYR's* 12.3.5 Architectural and Landscape Control.

Justification: This is now the new procedure in place.

CHANGE MASTER DESIGN COMMITTEE GUIDELINE CHECKLIST

Justification: Building permits are required by the MDC for new construction only (new home, guest house, or addition to existing construction). In order for your absentee ballot to be counted, it must be received at the Post Office no later than July 18, 2008.

Once cast, this ballot may not be revoked. This ballot may be cast only by the member to whom it is issued.

All absentee ballots received on or before the cutoff date will be used for quorum fulfillment purposes.

A quorum of the membership is 10% of all memberships.

Printed above the signature line on the ballot is information concerning your parcel number and number of memberships (votes). This information is taken from County Assessor Records. If you feel that this information is incorrect, please notify the association.

Each owner shall have the following number of memberships:

- ➤ One membership for each full acre in each lot or parcel owned by the member, but no memberships for fractional acres areas, and
- ➤ One membership for each one hundred (100) square feet of residential dwelling (including guesthouse) but no memberships for less than one hundred (100) square feet.

E.g. A member with a 2100 square foot house on an 8 acre parcel would have 29 memberships (votes).

Memberships and Voting are covered in section 6 of the CC&R's.
