# Minutes of the Meeting of 3 Canyons Ranch Master Homeowners Association (MHOA) Annual Membership Meeting Saturday July 21<sup>st</sup>, 2007, 10:00 AM, at Pueblo del Sol Country Club

### Call to Order

#### **Introduction of Board Members**

### **Discussion of Gate Relocation Project:**

Gate Committee Chair, Tom Pickering said the proposed (West) gate relocation looks "favorable", and on Friday (July 20<sup>th</sup>) Castle & Cook offered to lease land with perpetuity, at a nominal cost to 3 Canyons, for the purpose of relocating our West gate. Castle & Cook would build the monument structure for our new gate, and remove our old gate at their cost. 3 Canyons would purchase the new gate and control system. The new gate would be of Castle & Cook design, (presumably, to compliment other gates Castle & Cook will be installing in the vicinity) subject to 3 Canyons approval.

Members were provided the opportunity to ask questions, voice concerns and speak for or against the proposal.

Mr. Pickering stated that he would have to obtain a written proposal from Castle & Cook, and submit it to 3 Canyons Board of Directors, and attorney Bob Stachel for review.

## **Appeals Concerning Voting:**

A motion was made and seconded to increase the square footage of Donna Willard's home (Parcel 104-01-074) from 1998 sf to 2028 sf. (from 27 votes to 28 votes) The motion was carried unanimously.
