Minutes of the Meeting of 3 Canyons Ranch Master Homeowners Association (MHOA) Special Board of Directors (BOD) Meeting February 24, 2007, 10:00 AM, at Pueblo del Sol Country Club

Many of you may be aware of the law suit between San Pedro Development (represented by Ernie Graves) and Three Canyons HOA - concerning the status of the second phase of the Wild Horse development (Wild Horse II) i.e., whether Wild Horse II is or is not included in the Master Home Owners Association. Prior to the meeting, Three Canyons Counsel Bob Stachel summarized the settlement offer to the membership, and then introduced Judge James Conlogue.

Judge Conlogue answered questions from the membership concerning the settlement offer.

Acceptance of Agenda

A motion was made and seconded to adopt the meeting agenda. The motion to adopt the meeting agenda was carried unanimously

New Business:

Appeals Concerning Membership Records.

A motion was made and seconded that the records for Dennis Knowlton's parcel (#104-18-022) in Section 29 be changed to recognize a 2524 sq ft home in addition to his 4.66 acres for a new total of 29 memberships. The motion was carried unanimously.

A motion was made and seconded that the records for Sandy and Winston Witwer's parcel (#104-18-159) in Section 28 be changed to recognize a 2712 sq ft home in addition to their 4.12 acres for a new total of 31 memberships. The motion was carried unanimously.

A motion was made and seconded to accept Bob Schneider's parcel (#104-01-059H) in Section 27 as a full 8 acres for purposes of voting, assessments and setbacks. The motion was carried by a vote of 8 for, 1 opposed.

Announcement of Voting Results.

The Membership vote to accept the settlement offer from San Pedro Development passed by a vote of 6,176 (98%) for, 143 (2%) opposed. Of the total 11,689 memberships in the association, 6,319 (54%) votes were cast.
