# **Road Work**

Two quotes are expected to be received the week of December 9<sup>th</sup> from BNR Paving for both Bloomfield Road and Deer Ridge Trail, one for asphalt, the other chip sealing. According to Jay Satterwhite, the project will probably not begin until the spring of 2025 due to typical weather conditions in winter. Since both the Johnson and the Scott homes are complete, the repair work on Bloomfield should be done first. Charley Rule indicated that we could reinforce the interior area of the roundabout with concrete and do it ourselves since it will save money.

#### Minor Damage to Gate on Bloomfield/Survey Marker Caps

There was minor damage to the gate on Bloomfield road by someone who likely was directed to Deer Ridge Estates by Google MAPS. The gate is still functional and it was suggested that we place a sign on the post before the gate which says LOCKED GATE AHEAD in bold lettering similar to the one that is inside Deer Ridge land on Bloomfield and the cost would be under \$50.

A dead bird was found inside a survey marker by one of our residents. It would be best to either cap the survey markers or remove them. Jerry indicated most folks would prefer to leave their survey marker in place. Home Depot probably has PVC caps in stock for under a dollar ea. HOA could purchase.

# **Financials**
